2. HAZARDS IDENTIFICATION

Main hazards: Irritating to eyes.

3. COMPOSITION / INFORMATION ON INGREDIENTS

Hazardous ingredients: SODIUM PERBORATE TETRAHYDRATE 100.000%

4. FIRST AID MEASURES (SYMPTOMS)

Skin contact: There may be irritation and redness at the site of contact.
